## THIRD AND FOURTH EDITIONS OF TOP 500 INNOVATORS PROGRAM

In October 2012, two new groups of outstanding Polish

scientists and experts in technology transfer arrived at Stanford University and University of California at Berkeley to participate in the third and fourth editions of the Top 500 Innovators Program (the "Program"). Both Stanford (for the third time) and UC Berkeley have been selected by the Ministry of Science and Higher Education of the Republic of Poland (the "Ministry") as the most qualified institutions for the Program. Professor Piotr Moncarz, Chairman of USPTC, is the Academic Director of the Stanford program.

From April to June 2012, the second group of Program participants spent over eight weeks on professional development at Stanford.

The Ministry is planning to select up to five hundred of qualified Poles and send them to the world's Top Ten universities in order to enable the Program participants gain invaluable knowledge and experience on design-thinking, technology transfer, entrepreneurial activities, and multi-disciplinary team projects.

#### **US-POLAND INNOVATION HUB**

As announced at the Poland Day at Intel in March 2012, USPTC has initiated a US-Poland Innovation Hub program, aimed to serve as a Go-Global-Poland catalyst for small and medium size Polish innovative companies that are ready to brave the challenge of becoming global enterprises. The participants for the first edition of the program were selected from over thirty applicants eight of whom have already completed a series of preparatory training sessions in Poland that were conducted with the participation of USPTC-invited Silicon Valley and Polish experts (e.g., alumni of the Program). The first group of companies is preparing for their departure to Silicon Valley where, during a two- to four-week visit, they will participate in meetings and discussions with potential U.S. partners/investors.
